District Manager Sonnet Rodrigues reports Bob Parkins has been working with KSN and some consultants and has all the details worked out for KSN to submit CEQA documents. Approval for CEQA will take 6-9 months. Once the District gets approval we will go to bid.

4.3 Report and request direction of easement for potential solar at Safeway property:

District Manager Sonnet Rodrigues reports Scott's office took a lease agreement and turned it into an easement agreement. Downey Brand sent the proposed agreement to Renewable America for review.

4.5 Review and request direction on Encroachment removal project bids:

District Manager Sonnet Rodrigues reports there is a concrete pad and some piping near the South levee that gathers standing water and seeps through. The concrete pad is causing a visual block to monitor was is happening under the concrete pad. The District Manager Sonnet Rodrigues spoke with District engineer Christopher Neudeck about the concrete pad and pipes, District engineer Christopher Neudeck recommends removal. The District received three bids with AM Stephens Construction coming in at the lowest bid. District Manager Sonnet Rodrigues recommends accepting AM Stephens Construction bid.

There was a motion made by Trustee Morgan, second by Trustee Judge to approve the bid from AM Stephens Construction for the removal of the concrete pad and piping near the South levee.

The motion was passed 5-0

4.6 Report and request direction on Riprap supply project bids:

A brief discussion took place about the levee needing more rock the cost of the Riprap supply project exceeds 25k, the District has gone to bid for 175 truck loads of rock that will be placed by the District's maintenance crew. The bids will consist of 175 truck loads of rock, a water truck, road base, and a turn around. The district received five bids with Robert Burns Construction, Inc. coming in at the lowest bid. District Manager Sonnet Rodrigues is recommending accepting the bid from Robert Burns Construction, Inc.

There was a motion made by Trustee Morgan, second by Trustee Judge to approve to accept the lowest bid from Robert Burns Construction, Inc. for the Riprap supply project.

The maintenance crew confirmed there is a sunken hoist blocking the siphon to Willow Lake from the deepwater side. District Manager Sonnet Rodrigues gave the home owner 24 hours to remove the sunken hoist. A diver was sent down to take a closer look at the siphon, there was no visible debris blocking the siphon, there will be a camera sent down to the siphon to determine if there is any damage inside of the siphon or debris blocking the circulation that isn't visible by the diver. District manager Sonnet Rodrigues reports the maintenance crew remove tree debris from the Beach Ct. property. The maintenance crew trimmed palms in upper Willow Lake on one of the smaller islands. District manager Sonnet Rodrigues reports the maintenance crew mowed the North and South levee.
