District Attorney Scott Shapiro from Downey and Brand advised District Manager Sonnet Rodrigues and Trustee Morgan to speak with the County Supervisor in regards to the land use change and let the County Supervisor know how the land use change is impacting the District negatively.*

*District Manager Sonnet Rodrigues reports a benefit assessment meeting took place in January with Kim Floyd from Floyd communications, District Engineer Christopher Neudeck, Seth Wurzel from Larson Wurzel and Associates, Scott Shapiro from Downey and Brand, Trustee Judge, and Trustee Harris. The consultants determined the Drainage and Maintenance District needs to be included on the new website.
